INTRODUCTION

A.W. Research Laboratories (AWRL) photographed a fill location on Lake Sallie that was starting to wash away into the lake. Subsequently, the sedimentation's are forming a very large plume around the south end of the lake and towards the middle as well. This plume will have an effect on the water quality of Lake Sallie. To determine the extent of how this plume will affect the lake, AWRL proposes to map the sedimentation plume as described in the following proposal.

PROPOSAL

AWRL proposes to conduct a data collection overflight of Lake Sallie. This data will be processed using Water Watch™ computer software. Water Watch™ allows the user to map certain objects based on their spectral signature and false color the detected areas for easy identification.

Collected data of Lake Sallie will be processed using Water Watch™ and a false colored map of the sediments will be generated to aid in determining the extent of damages caused by the sediment disturbance area.

PERFORMANCE SPECIFICATIONS

The following conditions are to be met by A.W. Research Laboratories on acceptance of this bid:

- 1. All materials, supplies, labor, transportation, etc., will be provided by A.W. Research Laboratories.
- The final report will contain the following:
 - a. A false colored map showing the location and extent of the sedimentation plume.
 - b. 35mm color photographs of the area of concern along with the sedimentation plume.
 - Slides will be numerically correlated with a map for easy orientation.
 - Slides will be mounted in clear plastic slide pages for storage.
 - 3. Video data will be provided on a standard VHS tape.
- 3. Time table for the project:

The overflight will be conducted as soon as possible before settling of the sedimentation plume takes place.

Regulatory Authority: This Application will be reviewed according to the provisions of Sections Twelve (12), Fifteen (15), Ninetcen (19), of the Becker County Zoning Ordinance.
